**1. Eligibility:** The EF Beyond the Classroom Contest (the “Contest”) is open only to those who sign up at the online Contest page and who are sixteen (16) years of age or older as of the date of entry. The Contest is only open to students currently enrolled in a Canadian high school who are legal residents of Canada who reside in any province or territory within Canada and is void where prohibited by law. Employees of Square Crop Studios Inc., the parent company of Student Life Network (“The Sponsor”) their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Contest.
