

## **NO PURCHASE IS NECESSARY TO ENTER OR WIN.**

**1. Eligibility:** Campus Kick-Off Concert Giveaway - Chance To Win Your Tuition (the “Contest”) is open only to those who are planning to watch the Campus Kick-Off Concert, on September 10, 2020 and sign up at the [online contest page](#) and who are sixteen (16) years of age or older as of the date of entry who are residents of Canada who reside in any province or territory within Canada (excluding Quebec) and is void where prohibited by law.
