

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

1. Eligibility: Chance to Win Tickets to See Shawn Mendes (the “Contest”) is open only to those who sign up at the [online contest page](#) and who are thirteen (13) years of age or older as of the date of entry. The Contest is only open to students currently enrolled at a Canadian elementary school, secondary school, university or college who are residents of Canada who reside in any province or territory within Canada and is void where prohibited by law. Contestants will be asked to select one (1) of the following concert locations and dates upon entry into the contest:

August 21st, 2019 - Montreal, QC
