

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

1. Eligibility: SLN Access - Chance to Win VIP Tickets + Meet & Greet Suspending Gravity tour (the “Contest”) is open only to those who sign up at the [online contest page](#) and who are sixteen (16) years of age or older as of the date of entry. The Contest is only open to students currently enrolled at a Canadian elementary school, secondary school, university or college who are residents of Canada who reside in any province or territory within Canada and is void where prohibited by law.
